Introductions completed.

#### 2. Update of Vet Activities

Dolores Davison, Vice President of the Academic Senate for California Community Colleges, summarized work on prior learning credit. The Academic Senate has identified 6-7 courses/programs that are most common across the system. The intent is to create a crosswalk that assigns credit for various types/lengths of military work training. Evaluation of military credit resulting in uniform application to degrees/classes is an important priority. Formal articulation of the Joint Services Transcript (JST) was discussed.

#### 3. Operations Report

Nancy Montgomery, Irvine Valley College Assistant Dean of Health, Wellness and Veterans Services, provided the following report:

- The State of Veterans in California Community Colleges report and identified 6 (RP Group) key priorities based on data. The conclusion is we still do not know enough details on this population we serve.
- \$2 million grant and team with system representatives. Community Colleges have \$15 million to support Veteran Resource Centers (VRC) (ongoing). These funds should be going only to VRC expenses. Follow up surveys will be sent to determine where/how funds are being used.
- Advocate for a better support system for veterans thru VRCs. Looking to increase amount to provide base funding counselor/intake personnel. Data on female veterans is limited; however female veterans tend to have higher suicide rates, be single mothers, and have challenges with homelessness.

# 4. Legislative Updates

Legislative sessions have recently started, therefore more information will be available at the next meeting in May during the Annual Trustees Conference.

#### 5. Annual Plaque Award

There was agreement to present California State Senator Richard Roth the Annual Plaque Award in recognition of his support of Veteran students.

#### **Article I: Name and Logo**

### Section 1. Name of Organization.

The name of this organization shall be the California Community Colleges Veterans Caucus. It may be abbreviated to 'CCCVC'.

# Section 2. Organization's Logo.

The logo of the CCCVC shall be as illustrated on the attached Exhibit A.

#### **Article II: Mission Statement**

It shall be the mission of the CCCVC to work in affiliation with the Community College League of California and other appropriate veterans organizations providing a strong voice and representation within the League and promoting the welfare of veterans both through effective legislation and encouraging veterans to participate fully at all levels of policy making and public service.

#### **Article III: Membership**

#### Section 1. Values.

The CCCVC shall maintain the following seven core values: Leadership, Ethics, Action, Honor, Service, Unity and Excellence.

#### Section 2. Members.

Membership in the CCCVC shall be open to any person as an individual member, institution, or corporation who supports the mission of the CCCVC. Membership organizational levels shall be established and maintained by the Board of Directors.

# Section 3. Voting Members.

All members of the CCCVC in good standing may vote. Good standing shall be defined as being current on membership dues and compliant with the requirements of membership immediately prior to a vote. A voting process, including eligibility, shall be at the discretion of the Board of Directors.

#### Section 4. Student Representative.

A Student Representative from a member college shall be appointed by the Executive Committee to serve as a statewide student representative of the CCCVC and advise the

CCCVC with respect to Veteran student's needs and concerns. The Student Representative is a voting member and will serve for a period of two academic years. The Student Representative shall be supported by the District where the selected student is currently enrolled. The role of the Student Representative will be modified from time to time by the Executive Committee.

#### **Section 5. Operations Representative**

An Operations Representative from a member college shall be appointed by the Executive Committee and provide the CCCVC with Veterans Resource Center operations and student support perspectives. The Operations Representative is a voting member and the position is appointed each year.

# Section 6. Membership Dues.

- a) Membership renewal is due in July of each year.
- b) Dues are set by the Executive Committee annually and are offered at six organizational levels of membership; Individual, College, District, Multi-College District, Corporate Sponsor and 4 year College/University or Graduate Institution. A Community College or District member may designate up to (5) members who are employees of the college or District. A Corporate Sponsor or 4 year College/University or Graduate Institution member may designate up to (3) members who are affiliated with the corporation, 4 year College/University or Graduate Institution.

#### Section 7. Membership Termination.

- a) Membership in the CCCVC is a privilege. This privilege can be revoked by vote of a majority of the board of directors for conduct that is deemed harmful to the CCCVC.
- b) Any member may voluntarily resign their membership at any time. There will be no refunds for early resignation from the CCCVC. Members who resign are eligible for return to the CCCVC at any time by paying their dues and updating their information.
- c) Any member may be terminated for good cause as determined by the Executive Committee.

# **Section 8. Levels of Organization.**

The CCCVC shall have two levels of organization – Executive Committee and Board of Directors.

#### a) Executive Committee.

This Executive Committee serves as the steering committee of the CCCVC and acts on its behalf when a vote of the membership is not available. The Executive Committee will consist of the following officers:

- i. Trustee Co-Chair
- ii. Alternate Trustee Co-Chair
- iii. CEO Co-Chair
- iv. Alternate CEO Co-Chair
- v. Treasurer
- vi. Secretary
- vii. Operations Representative

#### b) Board of Directors.

The Board of Directors shall have up to twelve members. The membership shall consist of one director from each of the six state regions, two directors representing member Corporate Sponsors, two directors representing Veterans organizations, one Alternate Trustee Co-Chair, and one Alternate CEO Co-Chair.

### Article IV: Officers

#### Section 1. Officers of the CCCVC.

The CCCVC will have the following officers:

- a) <u>Trustee Co-Chair:</u> The Trustee Co-Chair position shall be held by a Trustee currently serving on an accredited community college board. The Co-Chair shall jointly preside over all general meetings of the CCCVC and represent the CCCVC on the Executive Committee of the CCLC. Should one of the Co-Chairs be absent for regularly scheduled meetings or other function that requires the Co-Chair's attendance or upon the occasion of a vacancy in one of the positions, the attending Co-Chair shall have authority to preside over the meeting.
- b) <u>Alternate Trustee Co-Chair:</u> The Alternate Trustee Co-Chair shall serve in the absence of the Trustee Co-Chair.
- c) <u>CEO Co-Chair:</u> The CEO Co-Chair position shall be held by a CEO currently serving at an accredited community college. The Co-Chair shall jointly preside over all general meetings of the CCCVC and represent the CCCVC on the Executive Committee of the CCLC. Should one of the Co-Chairs be absent for regularly scheduled meetings or other function that requires the Co-Chair's attendance or

upon the occasion of a vacancy in one of the positions, the attending Co-Chair shall have authority to preside over the meeting.

- d) <u>Alternate CEO Co-Chair:</u> The Alternate CEO Co-Chair shall serve in the absence of the CEO Co-Chair.
- e) <u>Treasurer:</u> The Treasurer shall promptly account for all CCCVC funds, and liaise with the CCLC to coordinate financial reports as required by the CCLC.
- f) <u>Secretary:</u> The Secretary shall keep the minutes of the CCCVC and be responsible for sending out correspondence as directed by the Executive Committee. The Secretary is responsible to maintain the list of voting members at meetings.

#### Section 2. Officers Elections.

Officers are elected during the CCCVC Officer Elections held at the November CCLC Annual Convention during odd numbered years. The term of office is two years. The Trustee Co-Chair and Alternate Trustee Co-Chair must be members in good standing with the CCLC and currently serving as Trustees on accredited community college boards. The CEO Co-Chair and Alternate CEO Co-Chair must be members in good standing with the CCLC and currently serving as CEOs at accredited community colleges. Corporate Sponsor members shall represent companies whose financial support is in place. Officers are elected by simple majority vote by all members present at the meeting.

#### Article V. Officer Replacement and Removal

#### Section 1. Replacement of Officers.

If an elected officer position shall become vacant at any time, for any reason, the Co-Chairs or Acting Co-Chair is to hold a special election at the next meeting of the Main Body as the first order of business, prior to the execution of the standard order of business. The Executive Committee is permitted to appoint an interim officer to fulfill the duties of the position for the time from the vacancy to the special election. In cases where one officer or two officers are the only remaining officers on the board for any reason, the Co-Chairs or Acting Co-Chair is permitted to directly appoint interim officers until a quorum of officers is reached and they shall appoint the remaining interim officers as prescribed.

#### **Article VI. Meetings**

# **Section 1. Meeting Requirements.**

- a) A minimum of five (5) voting members is required to qualify the presence of a quorum.
- b) The manner in which a CCCVC meeting occurs (in person, over the phone, online, etc.) shall be at the discretion of the CCCVC Co-Chairs, with care provided to ensure that the most inclusive of desiring participants is utilized.

# **Section 2. Notice of CCCVC Meetings.**

All members eligible to attend a meeting shall be informed of that meeting and receive an agenda a minimum of 2 weeks prior to the same. All meeting notices must contain information pertaining to the time and place of the meeting, the purpose of the meeting and any needs from potential attendees. Should all information not be readily available, notice with as much information as possible is still required. Once more information becomes available, the membership shall be informed within 24 hours of this availability. All meeting notices shall note that the bylaws, qualifications and procedures are posted on the website.

# Section 3. Rules of Meetings.

The CCCVC shall consult the *Robert's Rules of Order Newly Revised* as a reference for conducting meetings. It shall comply fully with all requirements of the CCLC and its Governing Policies in regard to its conduct and activity.

# Section 4. Meeting Provisions.

- a) All public CCCVC meetings shall be open to all members of the CCLC regardless of race, color, creed, national origin, sex, age, religion, ethnic identity, sexual orientation, gender identity, economic status, or disabilities as defined by the Americans with Disabilities Act of 1990.
- b) The CCCVC shall not discriminate on the grounds of race, color, creed, national origin, sex, age, religion, ethnicity, sexual orientation, economic status, or disabilities as defined by the American with Disabilities Act of 1990.

#### Section 5. Qualified Voters.

- a) A 'voting member' is a member in good standing at the time of the vote or vote deadline.
- b) The CCCVC Secretary will post a list of members in good standing in the meeting room and confirm that the people who are voting are in good standing.

#### **Article VII. Executive Committee Duties**

#### Section 1. Duties.

Duties of the Executive Committee shall be to exercise all executive powers on behalf of the Veterans Caucus between meetings. The Executive Committee shall inform the members of the Veterans Caucus of all decisions and recommendations made. As the Executive Committee is representative of the membership, no vote may be taken by secret ballot. Information regarding any such decision shall be provided at the next Main Body meeting in the form of the Executive Committee Meeting Minutes.

#### Section 2. Policies & Procedures.

The Executive Committee shall be given the ability to promulgate Policies & Procedures that compliment or clarify these Bylaws in accordance with Article III, Section VI.

#### **Article VIII. Board of Directors Duties**

#### Section 1. Duties.

Duties of the Board of Directors shall be to highlight and communicate Veterans issues to institutions in their regions and act as representatives of Veterans in their region. The Board of Directors shall solicit and support membership in the Veterans Caucus and serve as a communication network related to categorical programs and legislation.

#### Section 2. Board of Directors Appointments.

Members who are interested in serving on the Board of Directors may self-nominate on a voluntary basis. Directors will be selected from the interested parties by the Executive Committee.

#### **Section 3. Meetings of the Board of Directors.**

The Board of Directors shall meet two (2) times per fiscal year, or as often as needed, by teleconference.

#### **Article IX. Committees**

# **Section 1. Creating Committees.**

The Executive Committee may create Committees, as necessary, for a stated time and duration to accomplish the stated goal/mission.

#### Section 2. Committee Chair.

All Committees shall have a Committee Chair appointed by the CCCVC Co-Chairs or Acting Co-Chair. The Committee Chair serves at the pleasure of the Executive Committee. Committee Chairs are tasked with the appointment of the committee members. At a minimum, the Committee Chair shall select a Vice Chair and a Secretary.

#### Section 3. Removal of Committee Officers and Members.

Committee Chairs may dismiss any member from their respective committee at any time, and are only required to inform the Co-Chairs of the CCCVC of their reasons in a

timely manner.

# Article X. Parliamentary Authority

The CCCVC bylaws shall govern this organization and the members shall govern the bylaws through the process provided to them herein. In cases where the CCCVC bylaws shall conflict with the decisions of any part or whole of the CCCVC, the CCCVC bylaws shall supersede all until such a time where they are properly changed. In case of conflict in the CCCVC bylaws, the CCLC bylaws will be the governing document.

# **Article XI. Amendments of the Bylaws**

By unanimous consent of the Executive Committee, or by majority vote of members at a CCCVC meeting, the Bylaws may be amended. The Executive Committee shall take recommendations from members of the CCCVC.
